Mayor: Affidavits of Residency were submitted and Oaths of Office were administered by Mayor Buttorff for the following five (5) Council Members; Dr. John Pisarcik, 1st Ward; Janet Barnhart, 2nd Ward; Sean Simcox, 3rd Ward; Marguerite Dyroff, 4th Ward; and Michael Zellers, 4th Ward.

Mayor Buttorff asked for nominations to elect a Borough Council President. Councilor Scheesley nominated Marguerite Dyroff. A roll call vote was taken with all members of Borough Council voting unanimously to elect Councilor Dyroff as Council President.

Mayor Buttorff asked for nominations to elect a Borough Council Vice President. Councilor Dyroff nominated Kenneth Scheesley. A roll call vote was taken with Borough Council voting unanimously to elect Councilor Scheesley as Council Vice President.

Mayor Buttorff asked for nominations to elect a Borough Council President Pro Tem. Councilor Dyroff nominated Barbara Schmouder. A roll call vote was taken with Borough Council voting unanimously to elect Councilor Schmouder as President Pro Tem.


Mayor Buttorff turned the gavel over to President Dyroff.

Councilor Simcox made a Motion to make the appointments of Dan McClellan to a 5-year term to the Planning Commission; Lon Myers to a 3-year term to the Zoning Hearing Board; and Kenneth Scheesley, Bonnie Messersmith, and Shelley Moore each to 3-year terms to the Recreation Committee. Councilor Pisarcik seconded the Motion. The Motion carried 8/0.

President Dyroff stated that the Planning Commission and the Recreation Committee each had one vacancy and that any interested candidate would need to be a Borough resident. She stated candidates can drop off or send letters of interest to the Borough office.
