Mayor Thompson asked for nominations for Borough Council Vice President. Councilor Zellers nominated Kenneth Scheesley. A roll call vote was taken with Borough Council unanimously voting yes. Councilor Scheesley was elected Council Vice President 5/0.

Mayor Thompson asked for nominations to elect a Borough Council President Pro Tem. Councilor Zellers nominated Barbara Schmouder. A roll call vote was taken with Borough Council unanimously voting yes. Councilor Schmouder was elected President Pro Tem 5/0.

Mayor Thompson turned the gavel over to President Zellers.

<u>Council President</u>: President Zellers appointed Sean Simcox, Kenneth Scheesley, Joseph Hamm, Alternate, and Katie Ely, Member-at-Large to the Police Commission.

Councilor Scheesley made a Motion to reappoint Sean Simcox to the Planning Commission for a five-year term from January 1, 2020 to December 31, 2024. Councilor Bierly seconded the Motion. The Motion carried 5/0.

Councilor Scheesley made a Motion to reappoint David Hyde to the Zoning Hearing Board for a three-year term from January 1, 2020 to December 31, 2022. Councilor Schmouder seconded the Motion. The Motion carried 5/0.

Councilor Scheesley made a Motion to reappoint Cheryl Brungard to the Recreation Committee for a three-year term from January 1, 2020 to December 31, 2022. Councilor Schmouder seconded the Motion. The Motion carried 5/0.

Councilor Scheesley made a Motion to reappoint Tom Butzler to the Recreation Committee for a three-year term from January 1, 2020 to December 31, 2022. Councilor Barnhart seconded the Motion. The Motion carried 5/0.

Councilor Scheesley made a Motion to reappoint Matthew Haag to the Recreation Committee for a three-year term from January 1, 2020 to December 31, 2022. Councilor Bierly seconded the Motion. The Motion carried 5/0.

Councilor Scheesley made a Motion to reappoint David Palski to the Jersey Shore Area Joint Water Authority for a five-year term from January 1, 2020 to December 31, 2024. Councilor Bierly seconded the Motion. The Motion carried 4/0/1 with Councilor Barnhart, Councilor Bierly, Councilor Scheesley, and Council President Zellers voting yes and with Councilor Schmouder abstaining.

Council President Zellers presented the Council Committee appointments for 2020 through 2021.
